Chris Hansen appeared to represent this application. He said the addition of the pavilion is for his wife as an event planner for the business. They plan on holding weddings, Farmers market on Wednesday nights and events during the summer months. Summer hours are planned 4-7 with the option to 9:00pm. He has more than enough land for parking surrounding the proposed pavilion site. If there is inclement weather they plan on hanging side enclosures to the building.

No one appeared to speak in favor of this application.

Deb Lent 2175 Rte.14 a nearby neighbor to Climbing Bines. There are several single family homes in the neighborhood and she is concerned with the increasing business noise. How will the excess noise be controlled, what can she do.

She wants to enjoy her quiet nights in and outside her home especially in the summer months with her windows open. She asked if the Town has a noise ordinance. Who does she call if there is a noise issue?

Code Officer James suggested she should call Climbing Bines first to make them aware there is a problem. If the noise problem is not resolved she has the alternative to call Law Enforcement.

Mr. Hansen stated he would follow the noise law, reducing noise during the quiet hours.
