New Business-#15-8 Modification to Special Use Permit # 38-10 application of Climbing Bines Hop Farm LLC, 511 Hansen Point

WHEREAS, as an application a Modification SUP 15-8 was received on 12/1/15 from Climbing Bines Hop Farm LLC at 511 Hansen Point, for application # 15-8 requesting a special use modification to original permit # 38-10 to construct a 45' x 90' open sided pavilion to hold special events, in an Ag/Res District per Torrey Zoning and was filed with the Town of Torrey zoning Board of Appeals (hereinafter ZBA) and,

WHEREAS, after due public notice of such, a public hearing on said application was held by the ZBA on March 7, 2016 in the town meeting room at 56 Geneva Street, Dresden, Yates County, New York, at this time information was presented on the applicants behalf, and

WHEREAS, at said hearing all desiring to be heard were heard, and

WHEREAS: This application involves a Type II action as defined by the State Regulatory for Environmental Quality Review so that no further Environmental Assessment is required, now

THEREFORE BE IT RESOLVED that the application # 15-8 for Modification to Special Use Permit # 38-10 of Climbing Bines Hop Farm LLC 511 Hansen Point, to to construct a 45' x 90' open sided pavilion to hold special events, in an Ag/Res District is **GRANTED.**
