## Town Board Minutes April 11, 2017

The monthly meeting of the Torrey Town Board was held on Tuesday April 11, 2017 at 56 Geneva St. Dresden New York and called to order by Supervisor Flynn at 7:30PM.

Present: Supervisor Patrick Flynn, Councilman; Burge Morris, Colby Petersen, Peter Martini Excused: Councilman Lawrence Martin

Others present: George Thompson, Jim Riesenberger, Grant & Linda Downs, Mary Lilyea, Boy Scout Arik Homhouane and his dad, Nalong Hamhouane

Supervisor Flynn led the pledge of allegiance.

Mr. Flynn explained the town board's function and responsibilities to Arik who is seeking his citizenship badge in boy scouts.

Mr. Flynn presented the abstract of vouchers for review.

Motion by Mr. Morris, 2<sup>nd</sup> Mr. Martini that the bills on the General A & B accounts in the amount of 14,109.95 be paid, carried.

Motion by Mr. Martini 2<sup>nd</sup> Mr. Petersen, that the bills on the Highway DA & DB accounts, in the amount of \$6,137.70 be paid carried by all.

Motion by Mr. Morris, 2<sup>nd</sup> Mr. Martini re-appointing Chris Hansen to the Zoning Board of Appeal for a term to 2002 carried.

Motion by Mr. Petersen 2<sup>nd</sup> Mr. Martini, to re-appoint Michael Peacock, as Dog enumerator of 2017. He will be compensated at \$ 1.50 per dog, .54 per mile carried.

Discussion on penalties for watershed violations, motion by Mr. Martini, 2<sup>nd</sup> Mr. Morris to set penalty for any watershed violation up to \$ 250. fine and/or 15 day's imprisonment. This penalty will be at the discretion of the Court, carried by all.

Motion by Mr. Petersen 2<sup>nd</sup> Mr. Martini, to approve the minutes of the March meeting, carried by all.

Perry Point water supply meeting with officials of Town and Village of Dresden set for April 27, 2017 in the Town meeting room at 1:00pm.

Tim Chambers submitted his report as he is out of town. Torrey # 4 is presently having a new floor installed.

Motion by Mr. Petersen 2<sup>nd</sup> Mr. Morris to approve the February meeting minutes carried.

Dwight James gave the Code report. 2 Area variance applications, 1 steep slopes permit, permits issued in March 7, 1 violation,1 plans under review, 2 fire inspections, attended code school in Rochester, mileage for March9 -April 10- 334 miles

Mary Lilyea reported that the Greenidge Plant new assessment is 6.4 Million and the pipeline at 3 Million. In a pilot but fire tax will be paid which will lower the fire rate.
