Town Board Minutes March 12, 2019 Local Law 01-19 & Local Law 02-19

The monthly meeting of the Torrey Town Board was held on Tuesday March 12, 2019 at 56 Geneva St. Dresden NY and called to order by Supervisor Flynn at 7:30PM.

Mr. Flynn led the pledge of allegiance.

Mr. Flynn opened public hearings on Local Law 1-19 Tax Cap Over ride for 2020 and Local Law 2-19 Amending the Manufactured Homes Regulations in the Town Zoning Law at $7:35\,\mathrm{pm}$

No one appeared to speak in favor or opposition to LL 1-19 or LL 2-19, Mr Flynn went on to with other business.

Mr. Flynn presented the abstract of vouchers for review.

Motion by Mr. Martini, 2^{nd} Mr. Martin, that the bills on the General A & B accounts in the amount of \$ 12,093.66 be paid, carried.

Motion by Mr. Martini, 2^{nd} Mr. Downs, that the bills on the Highway DA & DB accounts, in the amount of \$ 4,715.39 be paid, carried by all.

Motion by Mr. Martini, 2nd Mr. Martin to approve February minutes with corrections noted carried by all.

Discussion on newsletter, will mail out, email and give copies to Mennonite school

for distribution. Motion by Mr. Martini, 2^{nd} Mr. Martin approving mailings, carried.

Mr. Downs reported the Dresden Fire Dept. is celebrating 150 Anniversary June $1^{\rm st}$.

The 2019 fund raiser will be serving breakfast 8-Noon on the $4^{\rm th}$ Sunday of each month at the firehouse. A decision was made to cancel the annual chicken Barbeque held in July as it has become increasingly harder each year to get workers for this event The Fire Dept. is in process of purchasing new firetruck and selling E-25 and R-3, no decision has been made on model of truck. Also, they are still in a membership drive.

Mr. Chambers gave the highway report.

New windshields on T-2 replaced Cracked and T-3 replaced pitted for around \$790.

Heater in shop repaired, converted to 24 volt from 110 volt by Jr. Heating of Nutt Rd.

Had a heating audit done by Airtite. Discussion on energy use in building.

He is seeking two proposals for new heating system in shop. He inquired if board made decision on purchasing mower for excavator, Mr. Martini stated at last month's meeting with Mr. Chambers concerned of possible budget deficit due to overtime cost, they agreed to wait til May for decision on new equipment purchases.

The mower used in cemeteries is in bad shape, would like to bid on a 2015 Husqavarna with 3 hours listed on Auctions International. Needs a narrow mower. He will bid up to \$3000.

Code Report submitted. Code Officer at required continued education training in Rochester.

The Town received a 2017 Dividend Premium from Selective Insurance for \$ 137.85

Discussion on Perry Point Water District. Whether the Town would be willing to do the administration of the water district. No action taken.

WHEREAS, the Town Board of the Town of Torrey, after due deliberation, finds it in the best interest of the Town of Torrey

to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Torrey hereby adopts said Local Law No. 1 of 2019, entitled, "A local law to override the tax levy limit established in General Municipal Law \$3-c", a copy of which is attached hereto and made a part of this resolution, and be it further

RESOLVED, that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Torrey, and to give due notice of the adoption of said local law to the Secretary of State of New York.

This by Roll call vote- Mr. Flynn - aye Mr. Martini - Aye, Mr. Martin - Aye, Mr. Downs - Aye (4 Ayes 0 Nays) Adopted.

Mr. Flynn closed the public hearing on Local Law 2-19 To amend the Manufactured Home Regulation in the town zoning law at 9:00PM Mr. Flynn read the SEQR Resolution:

WHEREAS, the Town of Torrey Town Board, hereinafter referred to as Town Board, has determined Local Law No. 2 of 2019 to be an Unlisted action under the State Environmental Quality Review (SEQR) Regulations, and,

WHEREAS, the Town Board has reviewed and accepted the Environmental Record prepared on said action, and

WHEREAS, the Town Board has considered the potential impacts associated with said action.

NOW, THEREFORE, BE IT RESOLVED THAT the Town Board makes this Determination of Non-Significance based upon: the Short Form Environmental Assessment Form, Parts 1 and 2, prepared for this action, Town Board Public Hearing Record on said action; and, the Environmental Record prepared on said action.

BE IT FURTHER RESOLVED THAT, the Town Board makes this Determination of Non-Significance based on the following reasons supporting this determination:

- 1. The Town Board considered the action as defined in subdivisions 617.2(b) and 617.3(g) of Part 617 of the SEQR Regulations; and,
- 2. The Town Board did review the EAF, the criteria contained in subdivision (c) of 617.7 and other supporting information to identify the relevant areas of environmental concern; and,
- 3. The Town Board did thoroughly analyze the identified relevant areas of environmental concern to determine if the action may have significant adverse impact on the environment; and
- 4. The Town Board did set forth its determination of significance in written form containing a reasoned elaboration and providing reference to all supporting documentation.
