Mr. Flynn led the pledge of allegiance.

Mr. Flynn presented the abstract of vouchers for review. Motion by Mr. Martini, $2^{\rm nd}$ Mr. Downs, that the bills on the General A & B accounts in the amount of \$ 14,547.28 be paid, carried.

Motion by Mr. Flynn, 2nd Mr. Downs, to appoint Patricia Brede as Sole Assessor for the Town of Torrey for the term of six (6) years to 2025, carried by all

Motion by Mr. Flynn, 2^{nd} Mr. Martini appointing to the Board of Assessment Review, Linda Lefko term to 2022 and Frank DiOrio term to 2024, carried by all.

Grant Downs presented letter from Mayor Bill Hall. Mr Hall reported Fire Department recent purchases. Due to NYS standards for safety changing, present equipment had to be updated. He included a description of the 2002 Rescue Pumper purchased and the description of two trucks 1991 Pumper and 1988 Rescue being replaced.

Clean up days are set for July 27 & 28 8-2 pm. Discussion on loads allowed being 2 per household and fees for tires \$2.,\$ TVs \$10-20,\$ bed mattresses/ box springs \$10 or 20. Set
