Mr. & Mrs. John Nolt appeared on this application.

Mrs. Nolt would like to operate a bulk food store on Hazard Rd. Her store has been operating for about 2 years already. Did not know that the town required permits.

Samuel Zimmerman spoke in support of this application. A grocery store is needed in the area and is a good service to the community.

No one spoke in opposition of this application.

Mr. Constatine asked if she already has any licenses.

Mrs. Nolt stated she licensed with NYS Ag & Markets. She has a home processing license.

STATEMENT OF THE CASE

This Public Hearing has been called upon the Special Use application # 20-4 of Samuel Zimmerman to operate a commercial dog kennel with 48 pastures on his property. A Special Use Permit is required in an agricultural district per Torrey Zoning Law § 98.33 f

*Copies of this application was given to the Town Planning Board for review.
Torrey Planning Board recommended approval of this application 8/17/20.*

Mr. Zimmerman has a commercial dog kennel constructed with 48 grass pastures for each dog. He presented professional photos of his operation. He has been raising dogs for sale for over 16 years. He discussed the size of each pasture to be 48' x 64'. Each dog house has a fresh water supply and is climate controlled. He has an onsite Vet available. All puppies are micro chipped and receive vaccines/shots from this Vet

When the puppies are gone the mother is placed with a companion animal, for socialization. Presently he has some puppies and older dogs on site.

John Nolt spoke in support of this application.

Katie Groet appeared with concerns for the dog's care. She stated the Commercial Dog Kennels aka "Puppy mills" she has visited, the conditions are deplorable. She works with Dog Rescue out of Monroe County.

She asked what happens to the females when they are "retired" from breeding.

Mr. Zimmerman stated the females are either given away or adopted out.

Ms. Groet reviewed photos of his dog kennel provided by Mr. Zimmerman. She is relieved that the dogs are not kept in cages. She asked if the dogs are auctioned.

Mr. Zimmerman stated no, auction dogs have higher risk of carrying diseases. He does not supply pet stores either.

Ms. Groet asked where he gets his breeders,

Mr. Zimmerman stated he only buys pure breds, no hybrids and that 90% of his stock are AKC.

Ms. Groet asked what happens to the puppies that do not get purchased.

Mr. Zimmerman stated due to Covid, there is a shortage of puppies, many people have the time to train puppies while at home during the pandemic. If he had puppies older than three month's he would reduce the price on them.

Mr. Gifford inquired as to state licensing for the kennel.

Mr. Zimmerman stated he is licensed with USDA who inspects the facility and NYS Ag & Markets.

No others appeared on this application therefore Chris closed the public hearing at 7:50pm.
