## Town Board Minutes July 9, 2024

The monthly town board meeting held on July 9, 2024 at 56 Geneva St. Dresden New York was called to order by Supervisor Peter Martini at 7:30PM.

Mr. Martini led the pledge of allegiance.

Doug Sinclair- Director of Yates Co Public Health, appeared to introduce himself.

Local news: Press releases/alerts regarding heat and power have been released through mass email since 2023.

Funding streams have been opened up to connect the Keuka Lake Outlet to Seneca Lake. The Village of Dresden, Greenidge Power Plant and Friends of the Outlet are also involved in this project.

Avian Flu has been identified in the nearby counties but not Yates.

Question about discharge from sewer plant into the Outlet. How can residents be alerted of the discharge concern.

Mr. Sinclair stated this may be accomplished by the email alert system.

**Abstract of vouchers -** Mr. Martini presented the abstracts. Motion by Mr. Downs,  $2^{nd}$  Mr. Petersen, that the bills on the General A & B Accounts in the amount of \$ 15,018.02 be paid, carried by all.

Motion by Mr. Downs,  $2^{nd}$  Ms. McGrath, that the bills on the Water District 1 in the amount of \$ 33,843.31 be paid carried.

Supervisor presented the Extension Agreement with Yates & Schuyler County for Shared use of John Deere 85G Excavator.

Motion by Ms. McGrath  $2^{nd}$  Mr. Petersen authorizing the Supervisor to sign the agreement for shared use of the John Deere 85 G Excavator carried by all.

Supervisor presented contract extension agreement from Nardozzi for Water District 1.

Motion by Ms. McGrath  $2^{\rm nd}$  Mr. Hendersen authorizing the Supervisor to sign the Contract Extension to August 2024 with Nardozzi, carried by all.

Supervisor presented the Pay app # 11 for Water District # 1 in the amount of \$ 66,685.39.

Motion by Mr. Downs  $2^{nd}$  Mr. Petersen approving the Pay app # 11 for Water District 1, carried by all.

Clerk reported Town received a Selective Insurance dividend check of 709.94.

Discussion on signing contract with Casella for monthly trash removal for \$ 51.00 per month with recycling. Tabled Tim Chambers would like to use local business. He will look into pricing from Cardinal Disposal of Dundee.

Clean up Day- 7 Roll offs 12 tons trash, collected \$288.50 for mattresses and 31 tires. Collected 1500 lbs of Ewaste.

**Highway Report:** Tim Chambers gave the highway report. The highway has installed bollard at public beach to prevent vehicles driving down walking path to lake.

Sent truck to work with Barrington, Milo, Starkey and Jerusalem on their road projects.

To date installed 25-meter pits for Water District 1. Mowing roadsides.

Worked on Anthony Beach Road lake access.

cross the ditch at.

Carlsen Rd Repaired pot holes and culvert, placed a children at play sign. A resident would also like a road speed sign to slow the cars down traveling west to top of road.

Mr. Chambers would need to contact the NYS DOT to do a traffic study as they determine what speed should be posted. He feels it is not necessary to post a lower speed sign as it could become problematic request from all over the town. Received a call from resident on Arrowhead Beach Rd requesting that site where a homeowner placed bridge across ditch was removed by highway during maintenance, be replaced with a culvert. Mr. Chambers feels this is not necessary. He stated there is a culvert already in place, a short distance from the resident's property that he can use to

East Leach Rd culvert plugging up and plan on replacing it tomorrow.

2019 Volvo recall, taking truck to Beam Mack tomorrow.

Mr. Chambers discussed a high medical insurance cost concern, Town is paying a higher rate for an employee who will not opt into a Medicare policy. Board will draft a letter informing employee of insurance options and their responsibility to pay difference for higher cost policy.
